

History of the club

Golf was first played at 'Strathfield Golf Club' in 1898, the 'new' Strathfield Golf Club was not formed until October 1931 and incorporated in 1934. Following its inception, the course consisted of 9 holes, eventually increasing in size to 18 holes.

Over the past few years Strathfield Golf Club has undergone a major redevelopment which includes the construction of a brand-new clubhouse and a major redesign of our golf course. Now complete, Strathfield Golf Club is a first-class facility and the perfect venue to host your next corporate day.

Facilities available include locker & change rooms, multiple meeting rooms, a business centre, function

rooms accommodating 300+ guests and a fleet of new electric carts. Along with panoramic views overlooking the course, the clubhouse is a perfect location for players to relax and reflect on their round, while enjoying a beverage and a meal with their playing partners.

Brand new redesign

The new layout, redesigned by Internationally acclaimed course architect James Wilcher from Golf by Design, plays as a championship quality 5,900-metre Par 70. The transformed course provides an enjoyable and challenging experience for golfers of all abilities.

A prominent feature of the course is the Cooks River which meanders its way through the centre of the course. It is crossed on six occasions, while coming into play on an additional three holes.

The course rewards length and accuracy off the tee and will often punish errant and mishit approach shots. All golfers will leave with memories of the pure undulating bent grass putting surfaces, and the stunning bunker complexes protecting the often-elevated greens.

Book now to be one of the first to experience the stunning new layout and state of the art clubhouse facilities that Strathfield Golf Club has to offer.

Golf Course Dress Code

Shirts: Men to wear shirts at all times and have a “fold over collar” or “mock collar”. Advertising logos or golf motifs must be limited to pocket size. Shirts may be worn outside if tailored to do so. Ladies to wear smart casual tops or sport shirts.

Shorts&Trousers: Belts should be worn (no drawstrings). Cargo shorts and trousers with outside pockets are acceptable. Denim shorts or trousers are forbidden on the course however tailored denim trousers may be worn in the clubhouse.

Socks: Socks must be worn when playing on the course predominantly white low-cut ankle or shorter crew length socks are acceptable.

Shoes: Soft Spiked Golf shoes or sport shoes to be worn on the course (no steel spikes or joggers). Enclosed boat shoes may be worn in the clubhouse without socks.

Caps: Caps must be worn in the appropriate manner and with the peak facing forward. Caps or hats must not be worn in the Clubhouse at any time.

Unacceptable Dress

- Board shorts, sports shorts, tracksuits, elastic or drawstring shorts/trousers
- Hawaiian style shirts or t-shirts, offensive or excessive printing or logos
- Football wear or beachwear
- Rubber thongs, sandals or massagers
- Camouflage shorts or trousers

Care of the Golf Course

All players are to carry and use a sand bucket to repair divots and pitch marks on greens. Bunkers must be raked after use.

Electric Golf Carts are to be kept at least 10 metres from greens where paths are not provided. No more than two persons are to travel on the golf cart at any one time.

Something to think about

Parking

Yes, there is 355 on-site parking spaces available for all guests.

Security Bond

A security bond will be required for all events at Strathfield Event Centre. The bond will be refunded within 7 days after the event, less any additional costs incurred.

Do public holiday & weekend surcharges apply?

Should you book a corporate golf day on a public holiday or weekend, additional staffing surcharges apply.



Terms & Conditions

Agreement

All prices quoted are GST exclusive, where GST is applicable. It is a policy of Strathfield Golf Club that event organisers are not permitted to provide their own food or beverage for events held at Strathfield Golf Club.

Booking Confirmation

Should you wish to confirm your event with Strathfield Golf Club, we will require a signed copy of the catering proposal returned to our office along with a 25% deposit of the estimated total cost of the function.

All other payments must be made 7 working days prior to the event date. Additional guest numbers will be invoiced immediately for payment prior to the event.

Player numbers

Strathfield Golf Club can host Corporate Days on Tuesdays, Thursdays and Fridays.

- Tuesday & Thursday morning (tee off prior to 12pm) – maximum 60
- Tuesday & Thursday afternoon (tee off after to 12pm) – maximum 144
- Friday morning and afternoon – maximum 144

Strathfield Golf Club operates corporate days on either a limited shotgun start for fields under 100 players or a full shotgun start for fields over 100 players.

Function Conduct

The client agrees to conduct any function in an orderly manner, respecting the rights of other clients and staff. All conduct must be in full compliance with all applicable laws.

Beverages & Responsible Service of Alcohol

Strathfield Golf Club practices Responsible Service of Alcohol and reserves the right to refuse service of alcohol to intoxicated patrons.

Refusal of service is at the sole discretion of management & staff who will take the relevant steps to prevent intoxication on our licensed events

Alcoholic Beverages may not be brought on to Club premises or golf course. Alcohol cannot be removed from the Club premises and must be consumed in the defined function areas.

Damage & Event Bond

The client accepts responsibility for costs for any equipment, third party equipment hire, furniture, fittings or parts of the building damaged by their delegates and guests.

Strathfield Golf Club will not accept responsibility for the damage, or loss of any property left on the premises prior to, during, or after the function.

Clients should arrange their own insurance where required. All events will be required to pay an Event Bond. This will be advised in writing in the original catering proposal. All Event Bonds will be refunded within 7 days post event, less any additional costs incurred.

Cancellation of Booking

Strathfield Golf Club, in good faith, undertakes to provide services detailed in the quotation. In the event that the client needs to cancel their function, the

following fees apply:

- Cancellation less than 4 weeks of the function – the deposit is forfeited
- Cancellation less than 14 days prior to the function – 50% of the total booking is payable
- Cancellation less than 7 days prior to the function – 100% of the total booking is payable

Unforeseen Circumstances

In the event of inability to comply with any of the provisions of agreed services by virtue of any cessation or interruption of electricity, gas, water supplies, industrial dispute or equipment failure, unforeseen contingency or accidents, Strathfield Golf Club reserves the right to cancel any booking and refund any prepayment for deposit without notice at any time.

Cancellation due to bad weather

Where Strathfield Golf Club closes the golf course and declares the course unfit for play the security deposit will be returned to the client conducting the golf day or an alternative date will be offered.

Catering arrangements will be available to proceed subject to discussion.

In the event the client wishes to cancel their event due to actual or potential bad weather and where the Club continues to make the course available, the client will be required to pay 100% of the total amount.
